## **GENERAL TERMS AND CONDITIONS**

### **1. AGE LIMIT**

The eligibility date for determining the age limit shall be the closing date for receipt of applications, i.e., the closing date of the advertisement.

Age relaxation shall be applicable to SC/ST/OBC/PwD candidates as per Government of India norms.

### **2. HOW TO APPLY**

- (i) Interested candidates shall appear for the walk-in on the prescribes date with the completed application form and all the necessary documents listed.
- (ii) Candidates applying for the posts of Project Engineer and Project Technical Assistant, who fulfil the prescribed qualifications, shall be required to appear for written test / skill test for the purpose of screening.
- (iii) No candidate shall be permitted to appear for the written test and/or interview without the filled application form.
- (iv) The results of the screening test (written examination) shall be declared, and only shortlisted candidates shall be called for interview, either on the same day or on a subsequently notified date.
- (v) The prescribed essential qualifications and experience are the minimum requirements. Mere possession of the same shall not entitle any candidate to be called for written test, skill test, or interview.

### **3. SELECTION PROCEDURE**

- (i) Candidates shortlisted through the screening test(s) shall be required to appear for a personal interview. The date, time and venue shall be notified online. Candidates are advised to regularly visit <https://sameer.gov.in/recruitment> for updates.
- (ii) Final selection shall be based on the performance of the candidate in the interview, which shall be conducted at the venue mentioned in the admit card, unless otherwise notified.
- (iii) Mere appearance in the screening test, document verification, or interview shall not confer any right to selection or appointment. Selection shall be subject to fulfilment of all eligibility conditions and satisfactory performance at all stages of the selection process.

### **4. GENERAL NOTES**

- (i) Only those candidates who possess the prescribed degree/certificate with a minimum of 55% marks or equivalent CGPA, awarded by the concerned university/board on or before the closing date of application, shall be eligible for consideration.
- (ii) The prescribed essential qualifications and experience are the minimum requirements, and mere possession of the same shall not entitle candidates to be called for written test, skill test, and/or interview.
- (iii) For Project Engineer positions, candidates who have already appeared in the final examinations between April and July for concurrent academic year and are awaiting results may also apply for the advertised positions. Appointment shall be subject to production of the pass certificate at the time of joining, provided they have secured 55% marks or equivalent CGPA in all declared semesters.

### **5. TERMS AND CONDITIONS OF APPOINTMENT**

- (iv) No TA/DA shall be admissible for appearing in the screening test and/or interview.
- (v) SAMEER reserves the right to accept or reject any candidature at any stage of the recruitment process without assigning any reason thereof.
- (vi) SAMEER reserves the right to cancel, restrict, enlarge, modify or alter the recruitment process, if circumstances so warrant, without issuing any further notice or assigning any reason.
- (vii) Candidates must ensure that they fulfil all eligibility conditions prescribed for the post applied for. In the event it is found at any stage of the selection process or thereafter that a candidate has furnished false or incorrect information, suppressed material facts, or does not meet the eligibility criteria, the candidature/service shall be liable to rejection/termination without notice.
- (viii) Candidates shall be required to produce all original certificates for verification at the time of interview.

- (ix) The appointment shall be purely on contractual basis and shall not confer any right to regularisation, absorption, or continuation of service in SAMEER.
- (x) The selected candidate shall have no claim or right for continuity of service or automatic extension of the contractual term.
- (xi) Experience beyond the period prescribed in the advertisement shall not be considered for grant of additional increments, and no candidate shall have any right to claim such increments.
- (xii) Candidates who have previously been engaged with any SAMEER Centre as Research Scientist, Project Engineer (PE), or Project Associate (PA) for an aggregate period of five (5) years or more shall not be eligible for appointment to the posts of Project Engineer or Project Associate.
- (xiii) Selected candidates will have liability to serve anywhere in the country.
- (xiv) Temporary accommodation, if available, may be provided as per the prevailing rules of the Institute on shared and payment basis. In case of violation of accommodation rules or misconduct in general the project staff will have to vacate the facility extended immediately as per the directions of the authorities.
